



FITNESS BOOT CAMP

I hereby affirm I am in good state of health and capable of participating in the fitness activities for which this assumption of risk is prepared. I am aware of all inherent dangers in exercise participation. I also acknowledge and fully understand I will be engaging in activities that involve risk of serious injury, including permanent disability or death, and severe social and economic losses which might result not only from my own actions, inaction, or negligence, but action, inaction or negligence of others, or the condition of the premises on or off site or of any equipment used and further, that there may be other unknown risks not reasonably foreseeable at this time. I assume all the foregoing risk and accept personal responsibility for the damages following such injury, permanent disability or death. I hereby release, discharge, covenants not to sue and/or otherwise indemnify Anthony Church, Rocco Church, Fitness Boot Camp, Ultimate Sambo Academy, and anyone associated with the implementation, direction, and instruction of the program in which I am enrolled, nor its affiliated organizations and sponsors, their instructors, managers, employees, members and associated personnel, officers, directors, agents, including the owners and lessees of premises used to conduct the activity (hereafter referred to as The Affiliated) and agree they are not responsible for the condition of workout areas off our premises. I understand that it is my responsibility to consult my personal physician to determine my eligibility to safely participate.

In consideration of participation, I do for myself, my heirs, executors, administrators and /or assigns hereby release, waiver discharge and relinquish any action or causes of action which may hereafter arise for my estate and agree that under no circumstances will I or my heirs executors, administrators and /or assigns prosecute or present any claim for personal injury, property damage, loss of consortium, or wrongful death against The Affiliated or representatives for any said causes of action, whether the same shall arise by the negligence of any said persons or organizations otherwise. I desire to participate in any or all activities offered by Anthony Church and Rocco Church in their Fitness Boot Camp program, and do so of my own free will. I hereby certify that I am of at least 18 years of age, am competent to enter into this agreement under New York law, or have had a parent or legal guardian read and sign this agreement.

Enrollment in the Fitness Boot Camp program is non-refundable. All sales are final.

Failure to attend workouts does not signify or imply notification to cancel payment. The Fitness Boot Camp program and any of The Affiliated may make any modifications in the workout schedule and program as deemed necessary. Such modification does not relieve the undersigned of their payment obligations under any circumstances.

The Affiliated reserve the right to use photographs, videotapes, artwork or other likenesses of the anyone participating in the Fitness Boot Camp program or inside the Ultimate Sambo Academy for the period of one half hour before the beginning of each fitness boot camp session, the

duration of each fitness boot camp session, and the period of one half hour after the fitness boot camp session, for marketing, publishing or any other lawful purpose.

Severability: If any provisions of this agreement shall be found invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable by the court of law.
